Procedure For Opt-Out/Opt-In Requests

1. Under the California Consumer Privacy Act of 2018 ("CCPA"), California Privacy Rights Act of 2020 ("CPRA"), and other applicable state laws, consumers may have the rights, as further described below, to opt-out, opt-in, or otherwise limit the sale or disclosure of their personal information. While individuals may have the right to opt-out of the sale of their personal information under the law, DaySmart does not sell personal information to any third parties, and therefore, DaySmart has not included a "Do Not Sell My Personal Information" link on its website nor does it provide any forms or information related to opting-out of the sale of information. If those practices change, DaySmart will update its policies and procedures and take any other necessary actions to comply with applicable law. does not sell the personal information of minors and will not sell such information without their affirmative authorization, or the affirmative authorization of their parent or guardian for minors under 13 years of age.

California Privacy Law Opt-Out and Opt-In Rights

1. Right to Opt-Out of the Sale or Other Disclosure of Personal Information

You have the right to opt-out of the sale of your personal information (as defined in our [Privacy Policy](#)) or sharing of your personal information for the purpose of targeted behavioral advertising. If you exercise your right to opt-out of the sale or sharing of your personal information, we will refrain from selling or sharing your personal information, unless you subsequently provide express authorization for the sale or sharing of your personal information.

2. Right to Limit Use of Sensitive Personal Information

You have the right to limit the use and disclosure of your sensitive personal information to the use which is necessary to:

- Perform the services or provide the goods reasonably expected by an average consumer who requests those goods or services;
- To perform the following services:
 - (1) Helping to ensure security and integrity to the extent the use of the consumer's personal information is reasonably necessary and proportionate for these purposes;
 - (2) Short-term, transient use, including, but not limited to, non-personalized advertising shown as part of a consumer's current interaction with DaySmart, provided that the consumer's personal information is not disclosed to another third party and is not used to build a profile about the consumer or otherwise alter the consumer's experience outside the current interaction with DaySmart;
 - (3) Performing services on behalf of DaySmart, including maintaining or servicing accounts, providing customer service, processing or fulfilling orders and transactions, verifying information, processing payments, providing financing, providing analytic services, providing storage, or providing similar services on behalf of DaySmart; and
 - (4) Undertaking activities to verify or maintain the quality or safety of a service or device that is owned, manufactured, manufactured for, or controlled by DaySmart, and to improve, upgrade, or enhance the service or device that is owned, manufactured, manufactured for, or controlled by DaySmart; and
- Use as authorized by further regulations.

You have a right to know if your sensitive personal information may be used, or disclosed to a service provider or contractor, for additional, specified purposes.
